SIR ROLAND WILSON FOUNDATION

SIR ROLAND WILSON 1904-1996

Sir Roland Wilson was an economist and acclaimed academic who had a remarkable career as a public servant. Born in 1904, Wilson was the first Rhodes Scholar from Tasmania. He completed two PhDs, one at University of Oxford and one at University of Chicago.

After a short academic career, Wilson joined the public service in 1932 and was quickly appointed Commonwealth Statistician. He then served as founding Secretary of the Department of Labour and National Service where he coordinated Australia's economic approach to World War II.

In 1951, he was appointed Secretary of the Treasury – he remains Australia's longest serving Treasury Secretary, with almost 16 years of service. He was remembered in this role as an intellectual force, giving expert advice that shaped economic policy.

After retiring from the public service, Wilson was Chairman on the boards of Commonwealth Bank and Qantas Airways. In recognition of his outstanding contribution to public service, Wilson was appointed a Commander of the British Empire (CBE) in 1941; a Knight Bachelor in 1955; and, a Knight Commander of the British Empire (KBE) in 1965.

DR PAT TURNER AM


The daughter of an Arrernte man and a Gurdanji woman, Pat was raised in Alice Springs. As CEO of the National Aboriginal Community Controlled Health Organisation, she is at the forefront of community efforts to Close the Gap in health outcomes for Aboriginal and Torres Strait Islander people.

Pat has over 40 years' experience in senior leadership positions in government, business and academia including being the only Aboriginal person, only woman and longest serving CEO of the Aboriginal and Torres Strait Islanders Commission.

Amongst her many appointments, she also spent 18 months as Monash Chair of Australian Studies, Georgetown University, Washington DC, and was inaugural CEO of National Indigenous Television.

Pat is the Coalition of Peaks Convenor and Co-Chair of the Joint Council on Closing the Gap. Pat holds a Masters Degree in Public Administration from the University of Canberra where she was awarded the University prize for Development Studies.

In 2024, The Australian National University awarded Pat the degree of Doctor of Letters honoris causa in recognition of her exceptional contribution to public service, her leadership and advocacy on Indigenous health and her academic achievements in the discipline of Australian studies.

ABOUT THE SIR ROLAND WILSON FOUNDATION

The Sir Roland Wilson Foundation is a partnership between The Australian National University (ANU), Charles Darwin University (CDU) and the Australian Public Service (APS).

Honouring the legacies of Sir Roland Wilson and Dr Pat Turner AM, we build research and leadership capability in the APS and embed connections between policymaking and academia through postgraduate scholarships.

The **Sir Roland Wilson scholarship** is a three-year, full-pay scholarship for PhD research at ANU for high performing EL1 and EL2 APS employees.

The **Sir Roland Wilson Pat Turner Scholarship** is a one-to-three-year, full-pay scholarship for any level of postgraduate study at ANU or CDU for high performing Aboriginal and Torres Strait Islander APS 4 to SES Band 1 APS employees.





FOREWORD

On 1 January 1901, the Australian Public Service (APS) was established as a cornerstone institution of Australia's democracy, with six founding departments: Attorney-General's, Defence, External Affairs, Home Affairs, Trade and Customs, Postmaster-General's, and the Treasury.

In 2024, the Sir Roland Wilson Foundation continued to invest in our role as a vital capability building tool for the Australian Public Service (APS), supporting the use of evidence in public policy and service delivery for all Australians.

Developing leaders with strong research and analytical skills, our footprint across the public service is growing - in 2024 we reached over 100 scholars and alumni from 26 Australian Public Service agencies.

We welcomed seven Sir Roland Wilson and nine Pat Turner scholars to The Australian National University (ANU) and Charles Darwin University (CDU). Six more scholars returned to the APS, putting their new knowledge and expertise to good use across different areas of policy and public administration.

I congratulate the 2024 prize winners: Natalie Bryant (Pat Turner Scholarship (Research) Prize), Dr Paul Hubbard (Ian Castles Alumni Prize), Helen Mitchell (Joan Uhr Prize), and Thaarramali Pearson (Pat Turner Scholarship (Coursework) Prize). Beyond award recipients, I have been impressed with the depth and breadth of the professional and academic impact of all our scholars and alumni in 2024.

Our events and activities in 2024 built networks to promote evidence-informed policy and support knowledge translation. The Foundation delivered a broad program of events and activities in 2024 – including the Wilson Dialogue, Commencement Dinner, Alumni Networking Reception, Pat Turner Scholar Forum, Scholar Symposium and Secretaries Dinner. Our pilot alumni mentoring program provided a platform for alumni to connect and share their knowledge and experience with scholars.

As our 2024 Secretaries Dinner Master of Ceremonies Mitchell Bird said so eloquently, the Foundation community's culture of 'connection, curiosity and contribution' is one of our strongest assets, supporting academic and professional excellence alongside wellbeing and resilience. When the Pat Turner Scholarship Program was launched in 2018, none of us could have predicted the extraordinary impact it would have. Reflecting on the program's growth over the past six years, I'm not only struck by the 37 scholarships awarded, but more importantly, by the lasting effects Pat Turner scholars and alumni are making across the Australian Public Service (APS) and in their broader communities.

2024 has been a year of pride and celebration for the Pat Turner Scholarship community, as well as for our partner institutions – The Australian National University (ANU) and Charles Darwin University (CDU).

One particularly remarkable highlight was the recognition of our namesake, Dr Pat Turner AM, who was awarded an honorary degree of Doctor of Letters honoris causa by ANU in July. This prestigious honour celebrates Pat's immense contributions to public service, leadership in Indigenous health, and her impressive academic achievements in Australian studies. We owe Pat an immeasurable debt of gratitude for her groundbreaking work, which continues to inspire the younger generation, including the scholars and alumni of the Pat Turner program.

Guided by Pat's example, our scholars and alumni have once again proven themselves to be trailblazers. CDU PhD candidate Lee-Anne Daffy made waves with a powerful exhibition that captured the attention of the ANU, CDU and APS communities. Meanwhile, fellow CDU scholar Ronald Fujii completed his Master of Public Policy with flying colours, earning the CDU First Nations Commonwealth Reward for outstanding academic achievement. Now, Ronald has been awarded a second Pat Turner scholarship to pursue a PhD at CDU in 2025, furthering his commitment to making a difference.

A key milestone in 2024 was the expansion of the program's influence in real-world policy. For the first time, four Pat Turner coursework scholars are actively engaged in applied research, working directly within their agencies to develop solutions for complex, real-world challenges.

This has allowed them to bridge the gap between academic theory and practical implementation, directly impacting public administration.

Scholars and alumni are also making significant strides within the APS. Eight Pat Turner scholars and alumni are now part of the APS Indigenous SES Network, which was chaired in 2024 by Pat Turner alumna Dr Lisa Conway. Additionally, two Pat Turner scholars earned promotions in the 2024 SES100 round, led by alumnus Dr Steve Munns. These successes reflect the power of the Pat Turner network in shaping the future of Indigenous leadership in Australia's public service.

The annual Pat Turner Scholar Forum in June was another memorable occasion. With an inspiring opening address from ANU Vice-Chancellor and President Genevieve Bell, attendees were treated to a keynote by former Productivity Commissioner Romlie Mokak. His words on strengthening the ability of scholars to influence policy from 'within the tent' resonated deeply with everyone present.

As always, the scholar lunch with Pat Turner, hosted by the Vice-Chancellor, was a highlight of the year. Pat's message was as powerful as ever: she urged scholars to be changemakers within government and to work toward improving the lives of Aboriginal and Torres Strait Islander peoples. Her pride in the program and its scholars was palpable, and she continues to be a guiding light for all involved.

I also want to take a moment to celebrate the outstanding achievements of the 2024 Pat Turner Prize winners: Thaarramali Pearson (coursework) and Natalie Bryant (research). And congratulations to Dr Lisa Conway for receiving the Australian Political Studies Association PhD Thesis Prize 2024!

I am continually inspired by the dedication and passion of the Pat Turner scholars and alumni. Their hard work not only furthers their academic pursuits but also helps to build a better future for their communities, families, and generations to come.

I am a strong believer in the transformative power of education, especially for Aboriginal and Torres Strait Islander Australians. The Pat Turner Scholarship Program, along with our growing "Team Pat" community, is living proof of that change. Together, we are making a difference.

 - · Wilson Dialogue featuring expert panels discussing cost-of-living and generational wealth inequality
- Four Pat Turner scholarships awarded for commencement in Semester 2 2024, four Pat Turner scholarships awarded for commencement in Semester 1 2025 and and five Sir Roland Wilson scholarships awarded for commencement in Semester 1 2025.
- Eighty-eight per cent of annual scholar survey respondents strongly agreed the Foundation builds capability and leadership of the APS, and 73 per cent strongly agreed Foundation programs and activities contribute to evidence-informed public policy.

- Piloted a mentoring initiative pairing experienced alumni with current scholars
- Onboarded four new members to the Alumni Advisory Group and facilitated an increased focus on knowledge translation
- Piloted a new poster exhibition at the 2024 Secretaries Dinner.

CREATING EVIDENCE TO BRIDGE THE GAP IN TORRES STRAIT SERVICE DELIVERY

Located north of Cape York Peninsula and south of Papua New Guinea, the islands of the Torres Strait are home to a wealth of history, culture and biodiversity.

Despite this abundance, life in the archipelago comes with a distinct set of challenges. The low-lying islands are particularly susceptible to climate change, with rising sea levels causing coastal erosion – damaging homes and infrastructure. Geographical isolation from the mainland means the cost of transport, essential goods and services is higher than in the rest of Australia.

Health care is much more complicated. With limited access to specialist care in the Torres Strait, Islanders with serious health conditions are often required to move to mainland Australia to access live-saving treatment. This comes at a cost and separates people from their culture and support networks.

"Local health centres offer limited services," Pat Turner scholar and Torres Strait Islander Ronald Fujii explains.

Ronald knows too well the challenges faced by his people.

"When it comes to health care, people prefer to receive treatment on Country."

With the support of his home agency, Torres Strait Regional Authority, Ronald completed a Master of Public Policy through Charles Darwin University (CDU) in 2024. He won the CDU First Nations Commonwealth Reward for outstanding academic achievement in Indigenous research.

"I wanted to better understand how policy arrangements can improve essential service delivery in the Torres Strait," Ronald said.

Ronald has been awarded a second Pat Turner scholarship to commence a PhD at CDU in 2025. His PhD will expand upon his masters research project with a focus on chronic illness.

"My PhD aims to examine and explore Torres Strait Islanders' involvement in health policy implementation at a grassroots level. I will explore the tensions between law and lore, inquiring into collaborative governance in health policy in the Torres Strait.

"The study focuses explicitly on Torres Strait Islanders – speaking with patients and carers through an ethnographic study, using community traditional governance processes.

"Torres Strait Islanders will have the opportunity to share their specific experiences and how they feel about health policy.

"This will create new evidence and ideas directly from Torres Strait communities."

Ronald says the research will have the potential to change the way Australian governments engage with communities in the Torres Strait.

He hopes to bring Traditional Owners along with him on his research journey.

"Developing my research in partnership with Traditional Owners means they will have the opportunity to collect evidence and data to support and influence change."

PROMOTING POST-TRAUMATIC GROWTH AND WELLBEING

The past five years have been challenging for many Australians. Traumatic events have been prevalent across the Australian community, including natural disasters and the COVID-19 pandemic.

This has been particularly acute for frontline workers.

"Specific workers, such as the military, emergency service personnel, journalists, justice and healthcare workers, can be exposed to potentially traumatic events through their ordinary work roles," Sir Roland Wilson scholar Jennnifer Wheeler says.

Jennifer explains a potentially traumatic event is any event that involves experiencing or witnessing actual or threatened death, serious injury or sexual violence.

It has been estimated up to three quarters of Australians will be exposed to at least one potentially traumatic event during their lifetime.

Historically, research has focused on the development of psychological disorders following exposure to a traumatic event, with post-traumatic stress disorder (PTSD) being the most widely researched stress-related disorder.

The Department of Defence scholar says "Focusing on a pathogenic framework following a traumatic event however, may not fully capture or reflect an individual's experience or functioning post trauma.

"A growing body of research has demonstrated some trauma survivors can experience positive psychological change following a traumatic event.

"Positive adaptation or change following a trauma has been termed post-traumatic growth or PTG."

"PTG has been shown to reduce the likelihood of trauma-related mental health problems and may lead to a higher satisfaction with life.

"PTG can also offer strong protective elements following exposure to a traumatic event, including a reduction in suicidal ideation."

Jennifer says initiatives designed to increase awareness of, and promote, PTG could lead to positive health and wellbeing outcomes.

Jennifer's PhD research examines awareness of PTG (also known as mental health literacy), in addition to piloting a preventive-focused PTG psychoeducation and skills development program.

Through her research, Jennifer is developing a bespoke scale which could be used to measure and report levels of PTG literacy within the community and in workgroups exposed to traumatic events.

"Mental health literacy is an important part of preventive healthcare – it can increase the likelihood of help-seeking behaviours, leading to an individual receiving appropriate health treatment."

One of Jennifer's research studies measured awareness of PTG and PTSD in a workgroup which has exposure to traumatic events. Interim findings found that most respondents were aware of PTSD, however less than one quarter had heard of PTG before.

"These findings show while there appears to be a general understanding of PTSD, what is less known is the potential for growth following a traumatic event."

To address this, Jennifer has developed and piloted a preventative-designed PTG psychoeducation and skills development program for Australian Defence Force members. This pilot program is designed to increase PTG literacy and confidence in skills, which have been demonstrated to promote growth following a traumatic event.

UNDERSTANDING PAST PANDEMICS TO INFORM FUTURE PUBLIC HEALTH RESPONSES

Throughout history, the world has experienced pandemics due to the plague, smallpox, cholera and influenza, but never one sparked by a coronavirus.

"Over the past century, there have been five pandemics, four of which were due to influenza, and each had differing degrees of severity and societal impact," Kate Pennington explains.

Kate is an epidemiologist and Sir Roland Wilson scholar from the Department of Health and Aged Care. She supported the government's responses to the 2009 influenza A(H1N1) and COVID-19 pandemics.

Her PhD research at The Australian National University examines how past pandemic assumptions shaped decisions for the public health response to COVID-19 and how these insights can apply to future pandemics.

"Before COVID-19, pandemic planning centred on influenza. Public health measures were geared toward mitigation, with little expectation that control or elimination was feasible."

"A coronavirus had never before led to a pandemic, which meant responses had to be rapidly re-orientated to COVID-19's characteristics."

Through all stages of a pandemic, evidence is crucial to the decisions you make, Kate explains.

"Understanding patterns of disease spread, severity and other characteristics of the virus are fundamental to informing effective public health responses." As part of her research, Kate is looking to make comparisons between influenza pandemic planning assumptions and how this shaped decisions for the COVID-19 response.

Kate's research could help Australia better prepare for and respond to future pandemics. She also sees potential for it to highlight the effectiveness of Australia's measures in averting the pandemic's severity compared to the impacts seen in many other countries.

Fresh from our studies and research, Sir Roland Wilson and Pat Turner alumni return to the Australian Public Service (APS) with new insights, a broad and influential network, and a strong commitment to progressing evidence-based policy and programs.

In 2024, we welcomed several graduates to our community – including Dr Cathy Fussell who graduated in July. Congratulations also to Claire Sainsbury and Timothy Watson who will graduate in February 2025.

If you look across the APS, you are increasingly likely to find a Sir Roland Wilson or Pat Turner alum making their mark – for example Dr Angelia Grant as G20 Sherpa at the Department of the Prime Minister and Cabinet, or Dr Steve Munns as Assistant Commissioner, Diversity and Inclusion at the Australian Public Service Commission.

You will find alumni in central agencies such as Department of Finance and The Treasury, but you will also find us in agencies as diverse as the National Library of Australia, the Torres Strait Regional Authority and Indigenous Business Australia.

Wherever you see us, you will find alumni leveraging their connections with academia, such as Dr Tristram Sainsbury at the ANU Tax and Transfer Policy Institute and Dr Christiane Gerblinger as a visiting fellow at the Australian Centre for Public Awareness of Science.

This year, the Alumni Advisory Group continued its program of engagement and activities, welcoming Padma Raman PSM, Executive Director of the Office for Women, as keynote speaker at the Alumni Networking Reception in April.

Regular policy reading groups have enabled alumni to maintain their connection to academic debate. This year, the groups discussed social policy and the cost-of-living; alternatives to top-down centralised leadership; and the future of the APS as a First Nations culturally safe and supportive workplace.

Alumni members have participated enthusiastically in the pilot alumni mentoring program, which connected alumni with current scholars. The benefits were two-way, and the program will be offered again in 2025.

We have continued informal networking gatherings throughout 2024. Joined by final year scholars, alumni at these gatherings have built meaningful connections and expanded their professional networks.

We congratulate Sir Roland Wilson alumnus Dr Paul Hubbard, who won the 2024 Ian Castles Alumni Prize. Paul's award is well deserved as he develops APS capability, builds links across the service and into academia, and shares knowledge.

We are privileged to have joined the Alumni Advisory Group as Co-Chairs in July and are looking forward to representing the interests of alumni over the next two years.

We thank the previous Alumni Advisory Group members Adina Jordan, Dr Nathan Deutscher, Carlyn Waters and Dr Rick Zentelis for their stewardship of the group.

On behalf of all alumni, we also thank the Foundation and its partners at ANU, CDU and the APS for their ongoing support of our endeavours.

Together with new members Dr Paul Hubbard and Kayannie Denigan, we look forward to creating opportunities for alumni to connect and translate their ideas and learning into stronger policy and service deliver outcomes.

ALUMNI IMPACT

A growing community of Sir Roland Wilson and Pat Turner alumni continues to make their mark across the Australian Public Service.

MORE THAN JUST A DEGREE

When she completed a Master of Public Policy at The Australian National University, Adina Jordan returned to the Australian Public Service equipped with more than just her degree.

The Sir Roland Wilson Pat Turner alumna said the course was a great opportunity to focus on the processes and practice of public policy through case studies and research.

"Understanding international public policy and our own historical context helped me gain insights into current policy approaches." Adina said.

Adina completed her degree in 2021 and returned to the Department of Social Services. Keen to apply her learning, she has continued to challenge herself including through a temporary transfer to the Treasury in 2024.

"My year in Treasury strengthened my knowledge of central government. This was a great opportunity to gain exposure to the intersections between policy and political systems, and develop a deeper understanding of the presentation of evidence in policy solutions."

While Adina's newfound knowledge has been invaluable in her post-scholarship career, the transferable skills she developed while studying have been equally useful.

"The real benefit has been the strong academic reading, writing and critical analysis and research skills I developed.

"These are highly transferable skills that allow me to gain a broad understanding of the context of an issue quickly, and then explore possible options or approaches to move the work forward."

Importantly, Adina has gained confidence.

"The scholarship created the space for me to develop my leadership skills and the confidence to apply academic knowledge beyond a 'western' viewpoint.

"Access to First Nations experts and academics (including outside my course) allowed me to develop my thinking across a range of related topics, bringing different viewpoints to the work of the APS."

Adina believes the Pat Turner scholarship is growing a community of strong First Nations thinkers and leaders who are working right across the Australian Public Service.

"Scholars and alumni are contributing to the APS, bringing a diversity of thought and cultural leadership that leads to better public policy and outcomes."

As an alumna, Adina has been committed to paying it forward to the Sir Roland Wilson Foundation community, serving for two years as Co-Chair of the Alumni Advisory Group. She also coordinates regular alumni policy reading groups for all Foundation alumni to discuss contemporary policy issues from various perspectives.

"I am keen to mentor those coming through the Foundation programs behind me – alumni have so much to offer in terms of guidance and support for the scholar cohort," Adina said.

AN ANU-APS BRIDGE BUILDER

Sir Roland Wilson alumnus Dr Paul Hubbard won the Foundation's 2024 Ian Castles alumni prize for his extraordinary efforts to forge connections between The Australian National University (ANU) and the Australian Public Service (APS).

When you look at what he has achieved since his graduation in 2019, it's no surprise he won.

In 2023 he was appointed a National Government Fellow at the ANU Crawford School of Public Policy to prepare a report on a sustainable economic partnership for Australia and China. This report was launched in May 2024 by the Secretary of the Department of Foreign Affairs and Trade.

Paul has created pathways into the APS for top students from ANU. Conversely, he has fostered a strong network of former ANU students across the service who continue to be engaged with research centres at the University.

Through the Masked Economist podcast, Paul interviews public servants, academics, Sir Roland Wilson Foundation alumni and other experts on key economic topics. Interviewees have benefited from sharing their ideas to an active and engaged audience.

The podcast broadly explores economics, public policy and APS careers.

"We've featured anthropologists, health economists, current and former ministers, secretaries and – of course – Sir Roland Wilson and Pat Turner scholars and alumni," Paul said. Paul started the Masked Economist during the COVID-19 pandemic as an online tutorial to help develop and maintain community in the economic division of the Department of the Prime Minister and Cabinet.

"When I moved to the Department of Finance, I took the initiative with me, but scaled it up to have more of an interview format that works better for a bigger audience."

The podcast has grown significantly since then.

"We now share the joy of economics with over 1,000 subscribers from more than 40 APS agencies."

Paul believes both the ANU and APS benefit immensely from healthy connections.

"Academics and policymakers are grappling with similar issues, but approach them through different lenses and time frames.

"Policy practitioners focus on what is immediate and practical - what they're responsible for in their agency. On the other hand, academics often have a view of a broader range of issues, so they can see things that policy people do not.

"By connecting the two sides, they inform and improve each other's work."

Now, as Co-Head of Al CoLab, Paul continues to build public service capability, providing a framework for using Artificial Intelligence (AI) collaboratively across the public service, academia and the private sector.

Paul's 'policy entrepreneurship' is having a real impact.

"When you strip away the jargon and complexity, it's pretty straightforward," Paul says.

"Collaboration makes better policy."




